**TERM AND CONDITIONS OF THE USE OF
HALAL CERTIFICATE AND LOGO**

1. The certificate of Halal and Logo awarded to the holders shall not be sold, transferred nor shall its content be altered.
2. The use of the certificate of Halal is subjected to the laws and regulations that are currently in force.
3. Any changes of the holders, companies or factories name, or address, brand name, suppliers, or anything relating thereto, shall be informed in writing to the Chief Executive Officer of HDC.
4. The holders shall be held liable for any misuse or fraudulent use of such certificate in accordance with the laws in force. In case of damages or lost, the certificate holder shall immediately inform in writing to the Chief Executive Officer of HDC.
5. The certificate granted may be withdrawn or its validity terminated when HDC has reason to believe that the holders are in breach of the "Guides Lines" or that the method or mode of conduct that is contrary to Islamic law.
6. The holder of such certificate shall only use it for such goods and at such premises as there in stated in the certificate.

**SYARAT-SYARAT PENGGUNAAN
SIJIL PENGESAHAN HALAL DAN LOGO HALAL**

1. *Sijil Pengesahan Halal dan logo ini tidak boleh diniaga, ditukar milik atau dipinda isi kandungannya.*
2. *Penggunaan Sijil Pengesahan Halal ini masih tertakluk kepada semua undang-undang atau peraturan yang berkaitan yang diamalkan di Malaysia.*
3. *Sebarang perubahan ke atas nama syarikat, kilang/premis dan alamatnya, jenama barang, bahan ramuan dan pembekal-pembekalnya serta apa jua yang berkaitan dengannya, hendaklah diberitahu kepada Ketua Pegawai Eksekutif HDC secara bertulis untuk tindakan selanjutnya.*
